I grant such persons the irrevocable, perpetual worldwide, and unrestricted right and permission to take, use, license, publish, and republish Content, as defined below, and to use the Content in composite or distorted in character or form, without restriction as to changes or alterations, in conjunction with my own or a fictitious name, or reproductions thereof in color or otherwise, made through any medium, and in any and all media for any legal purpose (except pornographic or defamatory) which may include, among others, advertising, promotion, marketing and packaging for any product or service. I agree that the Content may be combined with other images, text, graphics, film, audio, audio-visual works; and may be cropped, altered or modified, or distorted, including without restriction any changes or alterations as to color, size, shape, perspective, context, foreground or background. I agree that I have no rights to the Content, and all rights to the Content belong to the Company. 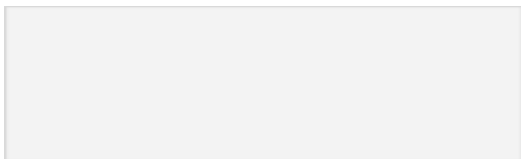
