In consideration of the engagement as a Model of the minor named below, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I hereby grant the following rights and permissions to High St. Graphics, LLC, including its photographers, filmmakers, licensees, and successors and assigns (the "Company"), and those for whom the Company is acting. I grant such persons the irrevocable, perpetual worldwide, and unrestricted right and permission to take, use, license, publish, and republish Content, as defined below, and to use the Content in composite or distorted in character or form, without restriction as to changes or alterations, in conjunction with the minor's own or a fictitious name, or reproductions thereof in color or otherwise, made through any medium, and in any and all media for any legal purpose (except pornographic or defamatory) which may include, among others, advertising, promotion, marketing and packaging for any product or service. I agree that the Content may be combined with other images, text, graphics, film, audio, audio-visual works; and may be cropped, altered or modified, or distorted, including without restriction any changes or alterations as to color, size, shape, perspective, context, foreground or background.

I agree that we have no rights to the Content, and all rights to the content belong to the Company. I acknowledge and agree that we have no right to additional consideration or accounting, and that we will make no further claim for any reason against the Company. We hereby waive any right that we may have to inspect or approve finished product or products and any advertising copy or other matter that may be used in connection with the Content or the use to which the Content may be applied.

We hereby release and discharge the Company, and those for whom the Company is acting, from any and all claims, demands, and causes of action that I or the minor may now have or may from now on have for libel, defamation, invasion of privacy or right of publicity, infringement of copyright or violation of any other right arising out of or relation to the rights and permissions granted herein.

I acknowledge and agree that this release is binding upon our heirs and assigns. It is agreed that our personal information (other than name) will not be made publicly available but may only be used directly in relation to the licensing of the Content where necessary (e.g. to defend claims, protect rights or notify trade unions) and may be retained as long as necessary to fulfill this purpose, including by being shared with sub-licensees/assignees of the Company and transferred to countries with differing data protection and privacy laws where it may be stored, accessed and used. I represent and warrant that I am a legal and competent adult and a parent or legally appointed guardian of the minor, and that I have every right to grant the rights and permissions granted in this release, and legally bind the minor to the provisions hereof.

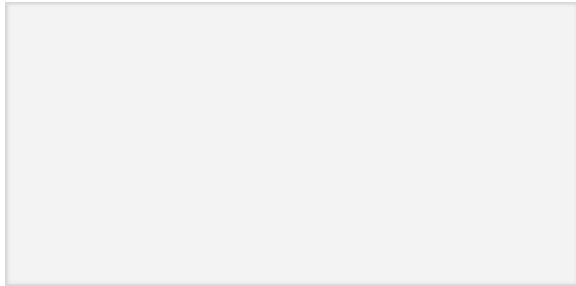
