## Release, Waiver and Authorization to Interview and Reproduce Voice and Physical Likeness (“Release”)

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I, the undersigned, do hereby grant **High St. Graphics LLC (the “Company”)**, and its affiliates, licensees, successors and assigns, and the employees, officers, directors and agents of each of them (collectively, “High St. Graphics”), for their own benefit and for the benefit of others, the right to record their interview(s) with me, and to reproduce and publish such interview, in whole or in part. I also grant to High St. Graphics the right to photograph me, or otherwise record my image, both in still and motion pictures, and to record my voice, separately and in synchronization with recorded images, still or in motion, by any means now known or hereafter to be discovered. I hereby waive the opportunity or right to inspect or approve any such Materials or the uses to which the same may be put. All copies of my image, likeness and voice created or recorded by High St. Graphics or its designees hereunder shall be the sole and exclusive property of High St. Graphics, including any and all prints and negatives depicting me. I hereby irrevocably transfer and assign to the Company my entire right, title and interest, if any, in and to the Materials and all copyrights in the Materials arising in any jurisdiction throughout the world, including the right to register and sue to enforce such copyrights against infringers. I acknowledge and agree that the Company has no liability to me for any editing or alteration of the Materials or for any distortion or other effects resulting from the Company's editing, alteration or use of the Materials. The Company has no obligation to use the Materials or to exercise any rights given by this Agreement, other than those obligations outlined in the Service Contract by and between the Company and \_\_\_\_\_, a copy of which is attached hereto as Exhibit A and made a part hereof.

To the fullest extent permitted by applicable law, I hereby irrevocably waive all legal and equitable rights relating to all liabilities, claims, demands, actions, suits, damages and expenses, including but not limited to claims for copyright or trademark infringement, infringement of moral rights, defamation, invasion of rights of privacy, rights of publicity, intrusion, false light, public disclosure of private facts, physical or emotional injury or distress or any similar claim or cause of action in tort, contract or any other legal theory, now known or hereafter known in any jurisdiction throughout the world (collectively, “**Claims**”) arising directly or indirectly from High St. Graphics’ exercise of their rights under this Release and the use and exploitation of the Materials, and whether resulting in whole or in part by the negligence of the

Company or any other person, covenants not to make or bring any such Claim against High St. Graphics and forever releases and discharges High St. Graphics from liability under such Claims.

I hereby warrant that I am eighteen years of age or older, that I am fully competent to execute this Release, and that no other agreements currently exist which would prevent my granting and transferring the rights granted and transferred to High St. Graphics herein. I acknowledge that High St. Graphics intends to rely on this Release and on the grant of rights herein contained and shall incur significant costs in production of the referenced work.

I intend that the form, terms and provisions of each paragraph of this Release be construed and enforceable to the fullest extent possible so as not to violate any applicable provision of law and, if necessary, are intended to be limited, by a court of competent jurisdiction, only to the extent necessary to render each such paragraph of this Release valid, legal or enforceable under the provisions of any applicable law. If any paragraph, term or provision of this Release shall be limited or modified, or held invalid, illegal or unenforceable, the validity of the other terms of this Release shall not be affected thereby.

This Release shall be governed by and construed in accordance with the internal laws of the State of Connecticut without regard to its conflicts of laws principles. Exclusive jurisdiction of any claim or cause of action arising out of or related to this Agreement shall be in the federal and state courts of competent jurisdiction in Connecticut, and I hereby consent to the exclusive jurisdiction of such courts.
